**DECLARING PUNONGBAYAN & ARAULLO  
INELIGIBLE TO BID  
FOR THE PROCUREMENT OF CONSULTANCY SERVICES FOR THE  
2012 RATE REBASING**

**WHEREAS**, the MWSS Board of Trustees (BOT) under Board Resolution No. 2012-038 dated 03 April 2012 approved the Procurement of the Consultancy Services for the 2012 Rate Rebasing under Contract No. RO-CS2012-001 with an Approved Budget for the Contract (ABC) of Philippine Pesos Sixty One Million Eight Hundred Sixty Thousand Six Hundred (Php61,860,600.00);

**WHEREAS**, the MWSS Regulatory Office Bids and Awards Committee (RO BAC) posted the Request for Expression of Interest (RFEI) in the website of the Philippine Government Electronic Procurement System (PhilGEPS) on 04 April 2012;

**WHEREAS**, RO BAC published the RFEI in the Philippine Star and Philippine Daily Inquirer on 05 April 2012 and 08 April 2012, respectively;

**WHEREAS**, eight (8) firms signified their interest and bought eligibility documents within the deadline set on 16 April 2012 at 4:00 P.M., namely:

1. Reyes, Tacondong & Co.
2. Gatmaitan & Associates
3. Angel Lazaro & Associates International
4. Punongbayan & Araullo / GTI
5. Manabat Sanagustin & Co. / KPMG
6. Isla Lipana & Co. / Pricewaterhouse Coopers in association with Poyry IDP Consult, Inc.
7. Sustainable Development Solutions
8. Rebel group International BV

**WHEREAS**, the RFEI set the deadline for submission and opening of the Eligibility Documents on 23 April 2012 at 2:00 P.M.;

**WHEREAS**, Punongbayan & Araullo / GTI submitted its Eligibility Documents within the deadline and its representative witnessed the opening of Eligibility Documents;

**WHEREAS**, during the opening of eligibility documents on April 23, 2012, the RO BAC initially declared Punongbayan & Araullo / GTI eligible, subject to a post verification of the eligibility documents;

**WHEREAS**, based on the physical examination conducted by the RO BAC Technical Working Group (TWG) of the submitted Eligibility Documents, it came out with the following observations which resulted in a failure to comply with the eligibility requirements, to wit:

1. Certain documents were not certified by the issuing office, agency or entity as required in the Instruction to Bidders, namely:
  - a. Annex "B" - SEC Registration Certificate;
  - b. Annex "C" - Certified copy of Deed of Articles of Partnership;
  - c. Annex "D" - Mayor's Permit;
  - d. Annex "E" - Certified copy of Certificate of satisfactory Completion of projects issued by the client; and
  - e. Annex "F" - Certified copy of NOA/Contract/NTP of awarded/on-going projects issued by client; and
2. Only the biodata or curriculum vitae of thirteen (13) of the 28 key personnel or professional staff were submitted;

**WHEREAS**, after a non-discretionary pass/fail criteria, in consonance with the bid documents and the provisions of R.A. 9184 and its IRR, the RO BAC decided to declare Punongbayan & Araullo / GTI ineligible to bid in view of the incompleteness of its submission;


