Envelopes containing the documents should be captioned "Contractors Confidential Statement of Qualifications" and submitted to the MWSS-Regulatory Office Bids and Awards Committee (MWSS-RO BAC), MWSS Compound, 3rd Floor Engineering Building, Katipunan Road, Balara, Quezon City. All documents submitted shall be treated as confidential and will not be returned.
- 6.0 Prospective bidders shall respond to all items in the CCSOQ. If the answer to any item is "Not Applicable" or "None" so state in the designated space. If there is no response for an item, the CCSOQ may be considered non-responsive and the CCSOQ may be rejected.
- 7.0 The MWSS-RO reserves the right to accept or reject any application without any liability to the affected applicants or any obligations to inform the applicants of the grounds for the action taken thereon.
