Please be informed that the Revised Rules and Administrative Cases in the Civil Service, Rule 10, D.8 provides that failure of officials and employees to file SALN, and disclose business interest and financial connections, including those of their spouses and unmarried children under eighteen (18) years of age living in their households is considered as a less grave offense punishable by suspension of one (1) month and one (1) day suspension to six (6) months for the first offense and dismissal from the service for the second offense.
