In connection with the filing and submission of the SALN form for 2019, we have attached a copy of the same as prescribed under Civil Service Commission Memorandum Circular (CSC MC) No. 04, s. 2016 for you to accomplish and to submit to the Administration Department-HR on or before June 30, 2020. Those who are on Work From Home Arrangement should also submit hard/signed copies of their SALNs to the Administration Department-HR on said deadline.

The SALN form and the "Guidelines on the Review and Compliance Procedures in the Filing and Submission of Statement of Assets and Liabilities and Net worth (SALN) and Disclosure of Business Interest and Financial Connection" dated September 27, 2019 are also attached in this MEMORANDUM.

Failure to submit/correct SALN in accordance with the procedures and within the given period shall be a ground for disciplinary action. The Chief Regulator shall issue a showcause order directing the concerned employee to submit his/her comment or counteraffidavit; and if evidence so warrants, proceed with the conduct of administrative proceedings pursuant to the 2017 Rules of Administrative Cases in the Civil Service.

Non-filing of the SALN shall be considered as an offense to be meted out with the following sanctions:

1st offense-Suspension for one (1) month and (1) day to six (6) months 2nd offense- Dismissal from the service

Likewise, pursuant to the previous issuances of the Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Information and Reporting Systems, officials and employees who fail to submit their 2019 SALN pursuant to the prescribed guidelines shall not be entitiled to FY 2020 WENG 9:15 JUN 10 2020 lan Performance-Based Bonus. LEGAL BASIS

1) 1987 Philippine Constitution;

2) Republic Act 6713 or the "Code of Conduct and Ethical Standards for Public

Officials and Employees";

 CSC Memorandum Circular No. 10, series of 2006 on the "Review and Compliance Procedure in the Filing and Submission of Statement of Assets, Liabilities and Networth and Disclosure of Business Interest and Financial Connections"; and

4) CSC Resolution Number 13000455 dated March 4, 2013 on the Review and Compliance Committee for the Statement of Assets, Liabilities and Networth (SALN)

GUIDELINES:

- All Plantilla-Based Personnel (Plantilla Personnel) shall file their SALN and Disclosure of Business Interest and Financial Connections to the Administration Department-HR, to wit:
 - a) Within thirty (30) days afer assumption of office, statements of which must be reckoned as of his/her first day of office;
 - b) On or before April 30 of every year therafter, statements of which must be reckoned as of the end of thr preceding year;



- c) Within thirty (30) days after separation from the service, statements of which must be reckoned as of his/her last day of office;
- MWSS RO talents must fill in all applicable information and/or make a true and detailed statement in their SALNs. Items not applicable should be marked N/A (not applicable).
- 3) There shall be a Review and Compliance Committee to receive, through the ALA-HR and to evaluate if the same has been submitted on time, complete and in proper form.
- 4) Duties of the Review and Compliance Committee

The Review and Compliance Committee shall prepare a list of the following employees, in alphabetical order to be submitted to the Chief Regulator and copy furnished the Civil Service Commission on or before May 15 of every year:

- a. Those who filed their SALNs with complete data;
- b. Those who Filed their SALNs but with incomplete data, and
- c. Those who did not file their SALNs.
- 5) Immediately upon receipt of the aforementioned list and recommendation, it shall be the ministerial duty of the Chief Regulator to issue and order those who have incomplete data in their SALN to complete/supply the desired information and those who did not file/submit their SALNs to comply within an non-extendable period of three (3) days from receipt of said order.
- 6) Assets and/ or properties acquired, donated or transferred for a particular year, but were not declared on their SALN for that year, as the same came to his/her knowledge only after he/she has filed, corrected and/or submitted his/her SALN, must be declared or reflected in the next or succeeding SALN.
- 7) Failure to correct/submit SALN in accordance with the procedure and within the given period pursuant to the compliance order shall be a ground for disciplinary action. The Chief Regulator shall issue a show-cause order directing the concerned employee to submit his/her comment or counter-affidavit; and if evidence so warrants, proceed with the conduct of the administrative proceedings pursuant to the 2017 revised rules of administrative cases in the civil service.

8) Failure to file SALN shall be considered as an offense with the following sanction:

 $1^{\rm st}$ offense – Suspension for one (1) month and one (1) day to six (6) months $2^{\rm nd}$ offense – Dismissal from the service

9) The ALA-HR shall transmit original copies of the SALNs received to the concerned offices on or before June 30 of every year.

MEMORANDUM CIRCULAR

TO

ALL HEADS OF CONSTITUTIONAL BODIES; DEPARTMENTS; BUREAUS AND AGENCIES OF THE NATIONAL GOVERNMENT; LOCAL GOVERNMENT UNITS, GOVERNMENT OWNED OR CONTROLLED CORPORATIONS; AND STATE COLLEGES AND UNIVERSITIES

SUBJECT

: Filing and Submission of the Revised Statement of Assets, Liabilities and Net Worth (SALN) Form for the Year 2020

Pursuant to CSC Resolution No. 2000523 dated April 3, 2020, the Commission resolves to adopt the following guidelines in the filing and submission of the Statement of Assets, Liabilities and Net Worth (SALN) Form for the year 2020:

- 1. All public officials and employees are given additional period of sixty (60) days from April 30, 2020, the last day of filing of the Statement of Assets, Liabilities and Net Worth (SALN) Form for the year 2019 pursuant to Section 8 of Republic Act No. 6713 (Code of Conduct and Ethical Standards of Public Officials and Employees), or until June 30, 2020, to file their SALN Forms with their respective agencies, unless the circumstances require otherwise.
- 2. Those filing their SALN Forms between the period after April 30, 2020 and June 30, 2020 shall not be subjected to any administrative case relating to the nonfiling of the SALN Form. However, those not filing their SALN Forms shall still be liable if they fail to file the same by June 30, 2020.
- 3. The last day of submission of the SALN Forms by all departments, agencies and offices to the appropriate repository agencies is extended from June 30, 2020 to August 31, 2020.
- 4. The foregoing parameters shall be subject to changes in case of any further issuances by the appropriate authorities, department and/or task force pertaining to the national emergency brought by COVID-19.

5. The proper form to be used by all public officials and employees for the annual filing and submission of the SALN for the year 2020 shall be the Revised SALN Form (Revised as of January 2015) together with the Additional Sheets Form (Revised as of January 2015).
