

CONTRACT AGREEMENT FOR SECURITY SERVICES

THE PUBLIC IS INFORMED:

THIS AGREEMENT made the 8th day of January 2021 between the **METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM (MWSS)**, a government corporation duly organized and existing under and by virtue of R.A. 6234, as amended, with principal business office at Katipunan Road, Balara, Quezon City, Metro Manila, through its **REGULATORY OFFICE (RO)**, herein represented by its Chief Regulator, **PATRICK LESTER N. TY**, duly authorized for this purpose by the MWSS Board of Trustees by virtue of Board Resolution No. _____ as part of this Agreement (called the **MWSS RO**);

GOLDEN Z-5 SECURITY AND INVESTIGATION AGENCY, INC., with principal business office at 363 Dr. Jose Fernandez St., Brgy. Highway hills, Mandaluyong City, Metro Manila, herein represented by its OIC for Overall Agency Operations, **ALMER P. CABUROBIAS**, by virtue of a Board Resolution No. 2020-1003 as part of the Bid from **GOLDEN Z-5**;

A N T E C E D E N T S:

WHEREAS, the **MWSS RO** is in need of a security contractor for the purpose of deploying licensed security guards to safeguard and protect its office premises, properties, equipment, facilities, and confidential information within its premises, against any and all unlawful acts by strangers or third persons.

WHEREAS, the security services engaged in this Agreement shall also cover the necessary security and safety measures for all RO officers, employees and its visitors transacting legitimate business in the **MWSS RO** premises;


WHEREAS, the **MWSS RO** Bids and Awards Committee (**MWSS RO BAC**) advertised the procurement of Security Services Contract No. RO-PG2020-001, on 7 October 2020 wherein only one (1) prospective contractor submitted their bid;

WHEREAS, in the bidding duly conducted, **GOLDEN Z-5** was declared the Single Calculated and Responsive Bidder that meets the standards of **MWSS RO** and complies with the Eligibility, Technical and Financial Requirements;

WHEREAS, the **MWSS RO** has accepted the bid of **GOLDEN Z-5** amounting to **One Million Five Hundred Thirty-three Thousand Seventy-One Pesos and 95/100 Only (Php1,533,071.95)** under the terms and conditions set forth in the Bidding Documents and herein below specified;


NOW THEREFORE THIS AGREEMENT WITNESETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a) Approved Terms of Reference (TOR) and the Approved Budget for the Contract (ABC);
 - b) Certificate of Availability of Funds;
 - c) Bidding Documents containing the following:
 - Section I. Invitation to Bid;
 - Section II. Instructions to Bidders;
 - Section III. Bid Data Sheet;
 - Section IV. General Conditions of Contract;
 - Section V. Special Conditions of Contract;
 - Section VI. Schedule of Requirements;
 - Section VII. Technical Requirements; and
 - Section VIII. Bidding Forms.
 - d) Bid Bulletin No. 01;
 - e) The supplier's winning bid comprising of the following:
 1. Eligibility and Technical Bid;
 2. Financial Bid/Proposal;
 3. Other documents/statements submitted (e.g. bidder's response to clarifications on the bid);
 4. Corrections to the bid resulting from the Procuring Entity's bid evaluation; **Abstract and Calculation of Bids**; and
 - f) RO-BAC Resolution declaring the bid of **GOLDEN Z-5** as the Single Calculated and Responsive Bid;

(Note: The following documents shall be submitted upon receipt of approval from the HoPE (MWSS BOT))

 - g) MWSS BOT Resolution No. 2020____-RO approving the award and Authorizing the Chief Regulator to enter into Agreement with **GOLDEN Z-5**;


- h) The **MWSS RO's** Notice of Award; and
- i) Performance Security.
3. The **MWSS RO** shall pay **GOLDEN Z-5** the total amount of **One Million Five Hundred Thirty-three Thousand Seventy-One Pesos and 95/100 Only (Php1,533,071.95)** annually in the manner and in accordance with Section VI, Schedule of Requirements, and Item No. 6 Administrative and Billing Requirements of Section VII, Technical Specifications of the Bidding Documents;
4. In consideration of the payments to be made by the **MWSS RO** to **GOLDEN Z-5** as hereinafter mentioned, **GOLDEN Z-5** hereby covenants with the **MWSS RO** to provide the goods and services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;
5. The **MWSS RO** hereby covenants to pay **GOLDEN Z-5** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract;
6. This agreement shall be for a period of three (3) years, to commence on the date as stipulated in the Notice to Proceed (NTP) up to a thirty-six (36) months period.
7. It is understood that no employer-employee relationship shall exist between **MWSS RO** and **GOLDEN Z-5's** employees and that **GOLDEN Z-5** assumes all responsibilities for its own employees;

IN WITNESS WHEREOF the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




