

## Contract Agreement Form

---

THIS AGREEMENT made the 17<sup>th</sup> day of February 2021 between **Metropolitan Waterworks and Sewerage System - Regulatory Office (MWSS RO)** of the Philippines (hereinafter called "the Entity") of the one part and **CRL Environmental Corporation (CRL)** of Clark Freeport Zone, Pampanga, Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS the **MWSS RO** invited Bids for certain goods and ancillary services, viz., water quality monitoring and has accepted a Bid by **CRL** for the supply of those goods and services in the sum of *nine million one hundred thirty-five thousand nine hundred pesos (P9,135,900.00)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the **MWSS RO** to **CRL** as hereinafter mentioned, the **CRL** hereby covenants with the **MWSS RO** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The **MWSS RO** hereby covenants to pay the **CRL** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. The agreement shall be for a period of one (1) year commencing from the date stipulated in the **Notice to Proceed (NTP)**. However, extension of this contract may be allowed, subject to Appendix 24-Revised Guidelines on the Extension of Contracts for General Support Services of the Implementing Rules and Regulations (IRR) of RA 9184.
