Answer to Email Queries

- a. An email was sent through the BAC Secretariat by Ms. Tescel Lyn C. Sunga of EGM Systems Global Technologies Inc. Ms. Sunga is seeking clarification regarding “Statement of the bidder’s Single Largest Completed Contract (SLCC) similar to the contract, completed within three (3) years prior to the deadline for the submission and receipt of bids.”

Her query was, EGM Systems Global Technologies Inc. had completed a project similar to the procurement project of MWSS RO and was already issued a Certificate of Completion and Acceptance by the Procuring Entity, the equipment has a Five (5) Year warranty which will remain active for several years. Ms. Sunga is asking if this would suffice in complying with the said requirement.

In response, as long as the prospective bidder have completed at least one (1) contract that is similar to the contract to be bid, and which value, must be at least fifty percent (50%) of the ABC to be bid and completed within three (3) years prior to the deadline for the submission and receipt of bids and are supported by a valid client / owner / Procuring Entity’s Certificate of Acceptance; the bidder may be considered compliant with the eligibility



criteria. The warranty is considered as an after-sales service and Certificate of Completion and Acceptance is acceptable regardless that the warranty of the equipment has not yet ended by the time of the bidding.

- b. From the same email of Ms. Sunga, she wants to clarify if the criteria “The Brand Manufacturer must be able to certify that they can provide at least 10 years guarantee on the availability of spare parts and service support” pertains only to the integrated rack cabinet and if it’s possible for the End-user to consider changing the guarantee years to five (5) years.

In response, we would like to clarify that the criteria “The Brand Manufacturer must be able to certify that they can provide at least 10 years guarantee on the availability of spare parts and service support” pertains only to the **Integrated Rack Cabinet**. With regards to the availability of the spare parts and service support, the End-user decided lowering it down to five (5) years from before ten (10) years. Considering the fast pace of technology, it would be more practical and realistic to come up to such decision. Please refer to the table below for the changes in the Bidding Documents.

Revisions are applied to the following:

- **Section III. Bid Data Sheet, ITB Clause 21.2 - Other Requirements;**
- **Section V. Special Conditions of Contract, GCC Clause 1, Spare Parts; and**
- **Section VII. Technical Specifications, One (1) Unit - Integrated Rack Cabinet, Additional Requirements**
