CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENT:

This Contract Agreement is executed and entered into for all intents and in all respects at Quezon City, Philippines on this AUG 0 6 Zudy of 2021, by and between:

The MWSS REGULATORY OFFICE, with principal office address at 3rd Floor, Engineering Building, MWSS Complex, Katipunan Road, Balara, Diliman, Quezon City, represented by ATTY. PATRICK LESTER N. TY, Chief Regulator, hereinafter referred to as the "ENTITY";

AND

ASAHI DESIGN CENTRE, INC., with business address at Unit 222, Teoff Center, 355 T. Pinpin Street, Binondo, Manila City, represented by MS. EREXEL SANCHEZ, Authorized Representative, hereinafter referred to as the "SUPPLIER."

WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Procurement of Supply, Delivery and Installation of Furniture and Accessories (Lot Nos. 1 and 2) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Twelve Million Ninety Eight Thousand Two Hundred Pesos (Php 12,098,200.00) (hereinafter called "the Contract Price"), to wit:

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act ("RA") No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (Annex A);
 - a. Schedule of Requirements;
 - Technical Specifications;

- General and Special Conditions of Contract;
- ii. Supplemental/Bid Bulletin No. 1 (Annex B);
- Notice of Suspension of Procurement Activities dated 10 May 2021 (Annex C);
- iv. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted (Annex D);
- v. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation (Annex E);
- vi. Performance Security (Annex F);
- vii. Notice of Award of Contract and Bidder's Conforme thereto (Annex G);
- viii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Twelve Million Ninety-Eight Thousand Two Hundred Pesos (Php 12,098,200.00) or such other sums as may be ascertained, the Supplier agrees to supply, deliver and install the goods stated in the PBD for the Procurement of Supply, Delivery, and Installation of Furniture and Accessories (Lot No. 1 and 2) in accordance with its Bid.
- The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Philippine Bidding Documents, RA No. 9184, its implementing rules and regulations, and other laws and issuances.
- 5. Any dispute arising from or in connection with the implementation of this Contract shall be submitted to arbitration in the Philippines in accordance with RA No. 876, the *Arbitration Law*, and RA No. 9285, the *Alternative Dispute Resolution Act of 2004*.
- 6. Should the Entity be constrained to resort to court action for any dispute in connection with or arising from arbitration to protect its rights and interests, the Supplier shall pay the Entity attorney's fees equivalent to 20% of the total sum claimed in the complaint, plus litigation expenses after judgment is issued and has become final and executory. The attorney's fees shall in no case be less than Fifty Thousand Pesos (Php50,000.00). Venue of all court actions shall be laid exclusively in the proper court of Quezon City.
