CASA BELLA HOME AND LIVING CORP., with business address at Ground Floor, AIC Burgundy Empire Tower ADB Avenue, Ortigas Center, Pasig City, represented by MS. TERESSA VILLANUEVA, Authorized Representative, hereinafter referred to as the "SUPPLIER."

WITNESSETH

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the Procurement of Supply, Delivery and Installation of Furniture and Accessories and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Five Million Four Hundred Twelve Thousand Three Hundred Twenty Pesos & 75/100 (PhP 5,412,320.75) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- 4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Philippine Bidding Documents, RA No. 9184, its implementing rules and regulations, and other laws and issuances.
