

## Contract Agreement Form

THIS AGREEMENT made the \_\_\_\_\_ day of 29 DEC 2022 20\_\_\_\_ between:

The **METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM REGULATORY OFFICE (MWSS RO)**, a government corporation duly organized and existing under and by virtue of Executive Order No. 149, Series of 2021, with principal business office at Katipunan Ave. corner H. Ventura St., Barangay Pansol, Balara, Quezon City, herein represented by its Chief Regulator, **PATRICK LESTER N. TY**;

-and-

**FIL-ANASERVE, INC. ("FIL-ANASERVE")**, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal business office at 2F MRL Tower 124 Malakas St., Central District, Diliman, Quezon City, herein represented by **LANCE MARVIN ILUMBA** by virtue of the Secretary's Certificate dated \_\_\_\_\_<sup>1</sup>;

In order to enhance its ability to effectively deliver its mandate of monitoring the compliance of the Concessionaires with their Service Obligations, particularly the provision of safe drinking water, the **MWSS RO** invited Bids for the "Procurement for the Design, Supply, and Installation of Laboratory Furniture and Equipment (Water and Wastewater Clean Rooms)" under Contract No. RO-PG2022-004 with an Approved Budget for the Contract of Six Million Philippine Pesos (Php 6,000,000.00), allotted among four (4) lots, as follows:

1. Lot 1 (Laboratory Furniture and Fixture) - PHP 1,876,000.00
2. Lot 2 (General Laboratory Equipment and Instrument) - PHP 845,377.00
3. Lot 3 (Microcystin Analysis Package) - PHP 1,950,000.00
4. Lot 4 (Multimeter for Algae and Chlorophyll) - PHP 1,328,177.00

After the conduct of competitive bidding pursuant to Republic Act (RA) No. 9184 and its Implementing Rules and Regulations, Lot 3 of "Procurement for the Design, Supply, and Installation of Laboratory Furniture and Equipment (Water and Wastewater Clean Rooms)" under Contract No. RO-PG2022-004 was awarded to **FIL-ANASERVE** with a contract amount of **ONE MILLION NINE HUNDRED FIFTY THOUSAND PHILIPPINE PESOS (PHP 1,950,000.00)**;

**ACCORDINGLY**, in consideration of the covenant and agreements hereinafter set forth, the **GOODS** to be delivered and **SERVICES** to be performed, as well as the sums of money to be paid, the Parties do hereby agree, as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

The Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;(b)

The Schedule of Requirements;

(c) The Technical Specifications;

(d) The General Conditions of Contract;

(e) The Special Conditions of Contract;

(f) The Performance Security; and

(g) The Entity's Notice of Award.

3. In consideration of the payments to be made by the MWSS RO to FIL-ANASERVE as hereinafter mentioned, FIL-ANASERVE hereby covenants with the MWSS RO to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The MWSS RO hereby covenants to pay FIL-ANASERVE in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. This Agreement shall be for a period of one (1) year commencing from the date stipulated in the Notice to Proceed. However, extension of this Contract may be allowed, subject to Appendix 24-Revised Guidelines on the Extension of Contracts for General Support Services of the Implementing Rules and Regulations of RA 9184.


