



NOTICE TO MANILA WATER CUSTOMERS AND THE PUBLIC NEW WATER RATES FOR THE EAST ZONE



Effective January 1, 2023, Manila Water Company, Inc. (MWCI) will implement the first tranche of the approved Rate Rebasing Adjustment equivalent to **30% and adjustment due to changes in Consumer Price Index equivalent to 3.73%** on the existing Basic Charge, based on MWSS Regulatory Office Resolution No. 2022-14-CA dated December 2, 2022 and as approved by the MWSS Board Resolution No. 2022-159-RO dated December 7, 2022.

Manila Water provides water and wastewater services to the following areas: Makati, Mandaluyong, Pasig, Pateros, San Juan, Taguig, Marikina, and parts of Quezon City, Manila and Paranaque. Angono, Baras, Binangonan, Cainta, Cardona, Jalajala, Morong, Pililia, Rodriguez, Tanay, Taytay, Teresa, San Mateo, and City of Antipolo in the Province of Rizal

** Low-income residential customers consuming 10 cubic meters or less will have a discounted rate. Low-income Customers are those qualified based on the definition provided by Article 1 of the Concession Agreement.
