



# NOTICE TO MANILA WATER CUSTOMERS AND THE PUBLIC NEW WATER RATES FOR THE EAST ZONE

Pursuant to the recommendation of the MWSS-Regulatory Office(RO) in RO Resolution No. 09-011-CA dated December 8, 2009, as approved by the MWSS Board of Trustees (BOT) in MWSS BOT Resolution No. 2009-074 dated Dec. 15, 2009 effective 15 days after publication in a newspaper of general circulation, Manila Water Company, Inc. (MWCI) will implement the second tranche/portion of the approved tariff adjustment equivalent to 5.33% of the Basic Charge as of Dec. 31, 2009 and the 0.20% change in the Consumer Price Index of the Old Rate, effective January 1, 2010 consistent with the MWCI's Concession Agreement Term Extension under MWSS BOT Resolution No. 2009-072 as approved on April 16, 2009 and confirmed on April 28, 2009. The Republic of the Philippines through the Department of Finance issued a Performance Undertaking on MWCI's Concession Agreement Term Extension on October 19, 2009.

Manila Water Company, the East Zone concessionaire, covers the following areas: **Manila** (San Andres and Sta. Ana only), **Quezon City** (east of San Juan River, West Avenue, EDSA, Congressional and Mindanao Ave., Districts of Tandang Sora, Pasong Tamo and Matandang Balara), **Makati City** (east of South Super Highway), **Mandaluyong City**, **San Juan**, **Marikina City**, **Pasig City**, **Pateros**, **Taguig** - all in Metro Manila; Rizal Province.

**B. Foreign Currency Differential Adjustment (FCDA)** - A percentage of the Basic Charge subject to periodic review and adjustment.  
The FCDA for the 1st quarter of 2010 is 1.58% of the new Basic Charge.

applicable to all customers of MWCI

**B. SEWERAGE CHARGE (SC)**  
20% of Water Charge for Residential and Semi Business  
35% of Water Charge for Business Group I and II customers
