NOTICE TO MAYNILAD CUSTOMERS AND THE PUBLIC
NEW WATER RATES FOR THE WEST ZONE



Effective 01 January 2023, Maynilad Water Services, Inc. (Maynilad) will implement a **Rate Adjustment Limit (RAL) of 13.10%** to be applied to its existing Basic Charge, as recommended by MWSS Regulatory Office (RO) in its Resolution No. 2022-15-CA dated 2 December 2022 and as approved/confirmed by the MWSS Board of Trustees' (BOT) Resolution No. 2022-160-RO dated 7 December 2022.

Maynilad is an agent and contractor of the Metropolitan Waterworks and Sewerage System (MWSS) for the West Zone of the Greater Metro Manila Area, which consists of the following areas: The cities of **Manila** (all but portions of San Andres & Sta. Ana), **Quezon City** (west of San Juan River, West Avenue, EDSA, Congressional, Mindanao Ave.; the northern part starting from Districts of the Holy Spirit & Batasan Hills), **Makati** (west of South Super Hi-way), **Caloocan**, **Las Piñas**, **Malabon**, **Muntinlupa**, **Navotas**, **Parañaque**, **Pasay**, and **Valenzuela** - all in **Metro Manila**; the cities of **Cavite**, **Bacoor** and **Imus**, and the towns of **Kawit**, **Noveleta** and **Rosario** - all in Cavite Province. Maynilad has 10 Business Area offices across the West Zone that serve its customers.

 0% of Water Charge for Residential and Semi-Business Customers
 20% for Water Charge for Business Group I and II customers
