

**NOTICE TO MAYNILAD CUSTOMERS AND THE PUBLIC
NEW WATER RATES FOR THE WEST ZONE**

Effective 15 days after publication, Maynilad Water Services, Inc. (Maynilad) will implement the **3.2% change in Consumer Price Index** to be applied to the 2012 Basic Charge as recommended by MWSS Regulatory Office (RO) in its Resolution No. 12-010-CA dated December 3, 2012 and as approved/confirmed by the MWSS Board Resolution No. 2012- 165 dated December 7, 2012. Also, the Foreign Currency Differential (FCDA) Adjustment will be negative 0.51% of 2013 Basic Charge as recommended by MWSS Regulatory Office in its Resolution No. 12- 012 -CA dated December 14, 2012 and as approved/confirmed by the MWSS Board Resolution No. 2012- 172 dated December 14, 2012.

Maynilad presently serves the West Zone which consists of the following areas: The cities of **Manila** (all but portions of San Andres & Sta. Ana), Quezon City (west of San Juan River, West Avenue, EDSA, Congressional, Mindanao Ave.; the northern part starting from Districts of the Holy Spirit & Batasan Hills), **Makati** (west of South Super Hi-way), **Caloocan, Pasay, Parañaque, Las Piñas, Muntinlupa, Valenzuela, Navotas and Malabon** - all in **Metro Manila**; the cities of **Cavite, Bacoor and Imus**, and the towns of **Kawit, Noveleta and Rosario** - all in **Cavite Province**. Maynilad has 12 Business Centers to serve its West Zone customers.

Maynilad Wins Global Honour Award

"This award is a testament to the hard work and dedication of the Maynilad organization, as well as the transformative management expertise of Metro Pacific and DMCI. But more importantly, it is a victory for the Philippines because we were able to prove that we could stand side by side with the best water engineering companies in the world," said Maynilad President and CEO Ricky P. The Global Project Innovation Awards recognizes innovation and excellence in water engineering projects around the world. It is organized by IWA, a global network of over 10,000 water professionals who collaborate to promote the development and implementation of innovative and effective approaches to water management.

B. CERA - P1.00/cu. m. of water consumption (incorporated in the Basic Charge on the Billing Statement of the customer)

C. FOREIGN CURRENCY DIFFERENTIAL ADJUSTMENT (FCDA) - Percentage of the Basic Charge subject to periodic review and adjustment.

The FCDA for the 1st Quarter of 2013 is **negative 0.51%** of the new Basic Charge.

2. A. ENVIRONMENTAL CHARGE (EC) - 20% of Water Charges

Applicable to all customers of Maynilad

B. SEWERAGE CHARGE (SC) for Customers Connected to Sewerlines

Applicable to Maynilad customers connected to sewerlines
0% of Water Charge for Residential and Semi-Business Customers
20% for Water Charge for Business Group I and II customers
