NOTICE TO MAYNILAD CUSTOMERS AND THE PUBLIC
NEW WATER RATES FOR THE WEST ZONE



Maynilad

Effective 15 days after publication, Maynilad Water Services, Inc. (Maynilad) will implement a **Rate Adjustment Limit (RAL)** of 2.8% which is the change in Consumer Price Index to be applied to the 2017 Basic Charge, as recommended by MWSS Regulatory Office (RO) in its Resolution No. 2017-11-CA dated 8 December 2017 and as approved/confirmed by the MWSS Board of Trustees' (BOT) Resolution No. 2017-158-RO dated 13 December 2017.

Maynilad is an agent and contractor of the Metropolitan Waterworks and Sewerage System (MWSS) for the West Zone of the Greater Metro Manila Area, which consists of the following areas: The cities of Manila (all but portions of San Andres & Sta. Ana), **Quezon City** (west of San Juan River, West Avenue, EDSA, Congressional, Mindanao Ave.; the northern part starting from Districts of the Holy Spirit & Batasan Hills), **Makati** (west of South Super Hi-way), **Caloocan**, **Las Piñas**, **Malabon**, **Muntinlupa**, **Navotas**, **Paranaque**, **Pasay**, and **Valenzuela** - all in Metro Manila; the cities of Cavite, Bacoor and Imus, and the towns of Kawit, Noveleta and Rosario - all in Cavite Province. Maynilad has 12 Business Area offices across the West Zone that serve its customers:

B. FOREIGN CURRENCY DIFFERENTIAL ADJUSTMENT (FCDA) -

A percentage of the Basic Charge subject to periodic review and adjustment.
 The FCDA for the 1st Quarter of 2018 is 0.60% of the new Basic Charge.

 Applicable to all customers of Maynilad

B. SEWERAGE CHARGE (SC) for Customers Connected to Sewerlines
 0% of Water Charge for Residential and Semi-Business Customers
 20% for Water Charge for Business Group I and II customers
