SUBJECT: Dividend Remittance to the National Government (NG)

Dear Administrator Cleofas:

In the interest of sustaining revenue generation efforts of the NG as we work towards building a resilient economy, the Department of Finance (DOF) is continuously pursuing the collection of dividends due to the NG from the GOCCs pursuant to Republic Act (RA) No. 7656 and its Revised Implementing Rules and Regulations (RIRR).

In this regard, we wish to remind you that pursuant to RA No. 7656 and Section 5 of its RIRR, all GOCCs shall annually declare and remit dividends to the Bureau of the Treasury (BTr) at least fifty percent (50%) of their net earnings on or before May 15 of each year. We would also like to emphasize the reportorial requirements stated in Section 6 of the RIRR of RA No. 7656 which should be submitted to this office simultaneous with the payment of the dividends to the BTr.

We shall appreciate your preferential attention on this matter.
