CONTRACT AGREEMENT

THIS AGREEMENT made the _____ day of $\begin{bmatrix} EB & 1 & 2024 \\ 20 & 20 \end{bmatrix}$ between METROPOLITAN WATERWORKS AND SEWERAGE SYSTEM REGULATORY OFFICE ("MWSS RO") of the Philippines (hereinafter called "the Entity") of the one part and GOLDEN Z-5 SECURITY & INVESTIGATION AGENCY, INC. ("GOLDEN Z") of Brgy. Highway Hills, Mandaluyong City, Philippines, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Security Services for Calendar Year (CY) 2024** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *TWO MILLION THREE HUNDRED SEVENTEEN THOUSAND SEVEN HUNDRED THIRTEEN PESOS AND 44/100 (PHP2,317,713.44)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz*.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins;
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning</u> <u>bidder agrees that additional contract documents or information</u> <u>prescribed by the GPPB that are subsequently required for</u> <u>submission after the contract execution, such as the Notice to</u> <u>Proceed, Variation Orders, and Warranty Security, shall likewise</u> <u>form part of the Contract.</u>
- In consideration for the sum of TWO MILLION THREE HUNDRED SEVENTEEN THOUSAND SEVEN HUNDRED THIRTEEN PESOS AND 44/100 (PHP2,317,713.44) or such other sums as may be ascertained, GOLDEN Z agrees to enter into Contract for the Procurement of Security Services for CY 2024 in accordance with its Bid.
- 4. The **MWSS RO** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
