

**CONTRACT AGREEMENT FORM FOR THE PROCUREMENT OF ANALYTICAL
SERVICES FOR WASTEWATER EFFLUENT MONITORING PROGRAM
(CONTRACT NO. RO-PG2023-002)**

THIS AGREEMENT made the _____ day OCT 05 2023 2023 between the **Metropolitan Waterworks and Sewerage System Regulatory Office (MWSS RO)** of the Philippines (hereinafter called "the Entity") of the one part and **CRL Environmental Corporation (CRL)** of Clark Freeport Zone, Pampanga, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the **MWSS RO** invited Bids for certain goods and ancillary services, viz., wastewater effluent quality monitoring and has accepted a Bid by the **CRL** for the supply of those goods and services in the sum of *One Million Nine Hundred Eighty-Four Thousand and Thirty-Five Pesos (P1,984,035.00)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the revised 2016 Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and constructed as part of this Agreement, viz.:

- (a) Philippine Bidding Documents (PBDs);
 - i. the Schedule of Requirements;
 - ii. the Technical Specifications;
 - iii. the General Conditions of Contract;
 - iv. the Special Conditions of Contract; and
 - v. Supplemental or Bid Bulletins.
- (b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluations;

- (c) Performance Security;
- (d) Notice of Award of Contract; and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warrant Security, shall likewise form part of the Contract.**

3. In consideration for the sum of *One Million Nine Hundred Eighty-Four Thousand and Thirty-Five Pesos (P1,984,035.00)* or such other sums as may be ascertained, the **CRL** hereby covenants with the **MWSS RO** to provide the goods and services and to remedy defects therein conformity in all respects with the provisions of its Bid and of the Contract.

4. The **MWSS RO** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

5. The agreement shall be commencing from the date stipulated in the **Notice to Proceed (NTP)** until 31 December 2023. However, extension of this contract may be allowed, subject to Appendix 24-Revised Guidelines on the Extension of the Contracts for General Support Services of the Implementing Rules and Regulations (IRR) of RA 9184.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


