

**CONTRACT AGREEMENT FORM FOR THE PROCUREMENT OF  
ANALYTICAL SERVICES FOR WATER QUALITY  
MONITORING PROGRAM 2024- LOT 1  
MICROBIOLOGICAL; AND PHYSICAL AND CHEMICAL PARAMETERS  
(CONTRACT NO. RO-PG2024-001-LOT1)**

THIS AGREEMENT made the 20<sup>th</sup> day of June 20 24 between the **Metropolitan Waterworks and Sewerage System Regulatory Office (MWSS RO)** of the Philippines (hereinafter called "the Entity") of the one part and **Mach Union Laboratories Inc. (Mach Union)** 335 Alabang-Zapote Road Talon 3, Las Piñas City, Metro Manila, NCR, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the **MWSS RO** invited Bids for certain goods and ancillary services, viz., water quality monitoring and has accepted a Bid by the **Mach Union Laboratories Inc.** for the supply of those goods and services in the sum of *Three Million Seven Hundred Sixteen Thousand, One Hundred thirty Pesos Only* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- (a) Philippine Bidding Documents (PBDs);
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. General and Special Conditions of Contract; and
  - iv. Supplemental or Bid Bulletins, if any
- (b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (c) Performance Security;
- (d) Notice of Award of Contract; and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security,


shall likewise form part of the Contract.

3. In consideration for the sum of *Three Million Seven Hundred Sixteen Thousand, One Hundred Thirty Pesos (P3,716,130.00)* or such other sums as may be ascertained, the **Mach Union Laboratories Inc. (Mach Union)** hereby covenants with the **MWSS RO** to provide the goods and services and to remedy defects therein conformity in all respects with the provision of its Bid and of the Contract.
4. The **MWSS RO** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The agreement shall be commencing from the date stipulated in the **Notice to Proceed (NTP)** until 31 December 2024. However, extension of this contract may be allowed, subject to appendix 24-Revised Guidelines on the Extension of the Contracts for General Support Services of the Implementing Rules and Regulations (IRR) of RA 9184.
